

## PUBLIX NEWS “LEGENDS” WORD PUZZLE CONTEST

### OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** The Publix News “LEGENDS” Word Puzzle Contest (the “Contest”) is sponsored by Publix Super Markets, Inc. (“Publix”). Contest is only offered in the states of Florida, Georgia, North Carolina, South Carolina, Alabama, Tennessee and Virginia (the “Contest Area”). Void outside the Contest Area and where prohibited.
2. Contest is subject to all federal, state and local laws. Publix shall be entitled to interpret these Official Rules as needed — including but not limited to rules regarding entries, deadlines, winner selection, prize restrictions, and eligibility — and all of its decisions are final.
3. Contest begins on March 5, 2019. Entry deadline is April 5, 2019 at 11:59 PM Eastern Time (“ET”). Potential winner will be determined on April 8, 2019. 4. To be eligible, each entrant must be a Publix associate, above the age of majority (or have consent of parent/guardian), and a legal resident of the Contest Area (above).
5. Prize (1): \$20 Publix Gift card. Approximate Retail Value: \$20. The entrant who submits the most valid words will be deemed the winner. Odds of winning will depend on the number of correct entries received. In the event of a tie, the winner will be selected via random drawing among the tied entries. 8. Additional Qualifications:
- a. In forming each word, you may only use letters from the following pool of letters: "L E G E N D S" (or, arranged in alphabetical order, D E E G L N S"). For illustration purposes, a valid word may include no more than one letter "D" but may include up to two letter "E"s.
  - b. All words labeled as a part of speech are permitted with the exception of the following words: abbreviations, prefixes and suffixes standing alone, and words requiring a hyphen or an apostrophe.
  - c. To receive credit for a word, such word must be defined in Merriam-Webster's English Dictionary.
  - d. Entrants may consult Merriam-Webster's English Dictionary to determine whether a word is valid prior to submission; however, entrants may not receive outside assistance or consult external resources, including online word generators, to assist with the formation of any words. Violation of this Section 8(d) will result in disqualification from the Contest.
9. All entries must be received by Publix no later than April 5, 2019 at 11:59 PM ET. Proof of sending is not proof of receipt by Publix. Publix will not accept screen shots as proof of entry. Regardless of method, limit one (1) entry per person. Additional entries received from any such person thereafter will be subject to disqualification.
10. Entrants who fail to provide any required information may be disqualified without further notification by Publix. Publix is not responsible for entries that are lost, misdirected, garbled, distorted, truncated, incomplete, illegible, incorrect or late for any reason, and all such entries are void. Publix reserves the right in its sole discretion to disqualify any entry at any time that in its opinion does not comply with these Official Rules. Entries become the property of Publix and may not be returned or acknowledged.
11. On April 8, 2019, or within a reasonable time thereafter, Publix or its designee will review the entries and determine the winner based on the entry with most valid words formed. In the event of a tie, the winner will be randomly selected from the tied entries. Winner will receive instructions on claiming or receiving prize. If prize is mailed or shipped, winner shall assume all risk of loss, damage, theft, late or missed delivery. If potential winner is determined to be ineligible or declines to accept the prize, Publix in its discretion may disqualify that individual and the prize will not be awarded.
12. Publix may, in its sole discretion, post the verified winner's name on the Contest Page and/or any of Publix's websites, including <https://blog.publix.com/news> and <http://www.publix.org>, and on or in any of Publix's social media pages or channels.
